- 5) To pay the appropriate service charge for any service required as a result of my carelessness or neglect in respect to the vehicle and equipment during the rental kind which may occur to any person or property arising directly or indirectly. I understand and agree to be responsible for and to indemnify and hold harmless Rental Wheels Ltd. (its Principles, employees and agents against all injury of any kind which may occur to any person or property arising directly or indirectly, whatsoever during the rental period of the said vehicle and equipment.
- 6) To pay the 5% surcharge on all credit cards.
- 7) To be responsible for the return of the vehicle and payment thereof until such times as a vehicle is returned to Rental Wheels office or (if pre-arranged) Marsh Harbour Airport.
